ANNUAL MEETING

Saude Congregation

The Annual Meeting of the Saude Lutheran Congregation was held on Wednesday, January 19, 1944. The meeting was opened by devotion conducted by Rev. N. S. Tjernagel.

The following pastoral report was read and discussed:

Membership of the congregation, 173; Communicant membership, 142; Voting membership, 57.

Official acts: Baptisms, 4; Confirmed, 2; Marriages, 2; Burials, 4; Communed, 269; Number of services, 40; (this does not include special services).

Average atendance at services, 73. Average communion attendance for the year, 1.9.

The minutes of the last Annual Meeting and of special meetings held on Dec. 17, 1942, April 11, May 30, and Nov. 8, 1943, were read by the secretary and approved.

The financial report was read by the treasurer and accepted.

The Cemetery report was read by Oscar Natvig and accepted.

Resolved to create a Board of Elders and to elect them in the same manner as the trustees.

Resolved to let the Board of Regents of Bethany Lutheran College decide on the most opportune time for the opening of a Seminary for the Norwegian Synod.

Resolved to nominate Dr. S. C. Ylvisaker and the Rev. G. O. Lillegaard for the two professorships of the proposed new Seminary.

Resolved to authorize the pastor to announce an offering for the Assistant Pastor and the Christian Day School in September in case the same arrangement is made for the pastor's assistance and the school as prevailed this year.

Resolved to continue the pastor's present salary for the coming year.

Resolved to instruct the officers of the congregation to hold regular quarterly meetings on the first Monday in March, and on the first Monday in every third month following.

The matter of the congregation's responsibility as legatee in the matter of the Emma Munson Legacy was discussed at length. The matter was tabled and a decision postponed until a later meeting.

Resolved to take part in the plan for the equalization of the travelling expenses of delegates to the Synod meeting as suggested by the delegates attending the last Synod meeting.

Meeting adjourned and closed with prayer.

ANNUAL MEETING

Jerico Congregation

The annual meeting of the Jerico Lutheran Congregation was held at the Jerico church basement on January 21, 1944.

The meeting opened with Scripture Reading and prayer conducted by the pastor.

The pastor read and commented on the following pastoral report:

Membership of the congregation, 413; Communicant membership, 319; Voting membership, 128.

Official acts: Baptisms, 6; Confirmed, 7; Marriages, 3; Burials, 1; Communed, 562; Number of services (not including special services), 46.

Average attendance at services, 116. Average communion attendance for the year, 1.75. This means that the average communicant received the Lord's supper less than twice during the year.

Resolved to elect a body of three Elders for the congregation, one to be elected from each district.

Resolved to instruct the officers of the congregation to hold regular quarterly meetings on the first Tuesday of March, and on the first Tuesday of every month thereafter.

Dr. S. C. Ylvisaker and Prof. C. A. Moldstad were nominated by the congregation for the two professorships of the proposed Theological Seminary of the Norwegian Synod.

Resolved to contribute the sum of \$31.90 (ten cents per communicant) requested by the delegates attending the last Synod meeting for the equalization of the travelling expenses of delegates to the next Synod meeting.

THE ELDERS OF THE CONGREGATION

One of the most important matters brought before the congregations at the annual meetings was the matter of Elders for the congregation. After the matter had been explained by the pastor, the congregations both decided to elect a Board of Elders. We would like to explain here more fully the purpose of such a Board, and say something about their duties.

We have a board of trustees as every incorporated body is required to have. These men are the legal representatives of the congregation in any legal matters that might arise. The congregation entrusts them with responsibility for the care and maintenance of the property of their church. Such property usually consists of a church building and the adjacent grounds, also of a parsonage. Thus the trustees are the stewards of the physical property of the congregation. They may also have other duties connected with the outward management of the congregation such as the collecting of funds for various purposes. In short, they are managers of the business affairs of the congregation.

The duties of the Board of Elders is quite different. Where the trustees are responsible for the outward business affairs of the congregation, the elders are chosen as assistants to the pastor in the spiritual affairs of a congregation. Every congregation has many problems that are in no way connected with its business affairs.

Indeed the principal function of a congregation is to preach the Gospel, to administer the Sacraments, and to admonish the erring. These duties are entrusted to the pastor whom the congregation has called. But it frequently happens that in carrying out these duties the pastor finds himself in need of help such as might be given him by wise and discreet and respected members of the congregation. Should the pastor go to this or that member for help he would invariably be accused of having favorites among the members to whom he went for help and advice. Should the time come that such persons would need to be asked to do something they might properly say that it is not their duty to become involved in the matter in question.

For these reasons most congregations elect Elders, to whom the pastor may go for assistance in carrying out the spiritual work of the congregation. They can be of invaluable assistance in many ways in advising their pastor in the many problems that are presented in the spiritual life of a congregation.

They also have another important responsibility. No pastor is by any means infallible. The best intentioned pastors are guilty of errors in judgment, and they have many failings which may be evidenced in every field of their labors. The Elders should consider it their very special duty to talk to their pastor about his failings and shortcomings with an earnest desire to help him to be a better steward of the souls entrusted to his care.

It is the prayer of your pastor that the election of a Board of Elders may be a very great blessing to the congregations.

QUARTERLY MEETINGS

Another resolution, which we believe will mean much in the congregational life of both congregations, adopted at the annual meetings was one which instructs the officers of the congregation (nine men in each case) to hold regular quarterly meetings.

We are sure that this will result in a better carrying out of the work of the officers of the congregation. It will also give the pastor a better and more frequent opportunity to discuss with the officers the problems of the congregations.

Matters of current importance will be discussed at these meetings, and the pastor will always have some matter to discuss at greater length.

There is so little time at the annual meetings to discuss anything but the most pressing questions. There is no time to discuss calmly and with sufficient time the many things that are so vital to a congregation's welfare.

We hope that the officers will attend these meetings faithfully, and that they will frankly present to these meetings any matter which they feel to be in the best interests of their congregation's welfare.

OBITUARY

Knute J. Knutson, son of Jetmund Knutson and his wife Anna Vanberg Halvorson, was born in Dane County, Wisconsin, on the 18th of February, When he was six weeks old, his parents immigrated westward in a covered wagon to establish a home at Vermillion, South Dakota. But, as was the case with so many other families, the Knutsons were obliged to leave their new home hastily after only three years' residence in South Dakota because of the spreading and bloody Indian uprisings of those times. After a perilous trip, the family stopped at the present site of Cedar Falls, Iowa, and sought to build a new home there. But after two years, the Knutson family was obliged to move again. This time it was because the family could no longer be content to dwell in a community where there was no church of their faith. It was for that reason that they moved to the Jerico community,

where the family became members of Jerico Lutheran Church, in which church the second, third, and fourth generations of Knutsons still hold membership. The deceased was baptized in Wisconsin, and confirmed by Rev. J. Moses, pastor of the Jerico Lutheran Church.

Mr. Knutson resided for 79 years at the home from which death has now taken him. The eldest son of Mr. and Mrs. Jetmund Knutson, he continued to live in the old homestead until the present time. Through a long life that extended nine days past his 84th year, the deceased enjoyed a rugged health. Six years previous to his death he suffered from a serious infection of the blood stream, and a few weeks ago he had undergone a minor operation. During these later years of his life he suffered from the infirmities of old age. On February 24, he had risen from bed as usual, but soon after breakfast he was stricken suddenly by a stroke from which he did not regain consciousness. Death came peace-

fully to him in St. Joseph's Mercy Hospital, at New Hampton, on Sunday morning, February 27, 1944.

He is preceded in death by his parents, by two brothers, Albert who died in 1941, and Ole who died in infancy; by four sisters, Mrs. Eli Bastesen, Kari, Johanna, and Anna.

He is survived by his beloved niece, Mrs. Sever Fossen, whom he brought up and cared for, and who, with her husband, gave him loving care during his declining years; by one brother, Ole, who resides at Jerico, and a sister, Mrs. Lena Moen, of Cresco, Iowa. Also by a number of cousins, and by many nieces, nephews, as well as many grandnieces and nephews.

He lived a faithful member of his church, and God gave him all the things He promises to His children, the things needful for this life, and the blessed assurance of salvation in Christ after this life. Blessed be his memory!

Interment was at Jerico Lutheran Church on February 29, 1944. The funeral sermon was based on the words of Joshua 23, 14.
